SYLLABUS

Welcome to Business Associations (LAWS 609). I will do my best to make your experience in this course worthwhile, and in turn I will expect from each of you full engagement and dedication to learning together as an intellectual community.

The course surveys the law of agency, partnerships, corporations, and LLCs.

Please read this syllabus carefully. It explains how the course will be taught and graded.

Course objectives:

The goal of this course is to help you develop a basic understanding of the theory, doctrine, and practice of business law. In addition to the goals below, I hope that you will further develop the analytical and professional skills to become a thoughtful practicing attorney who contributes to our society.

By the end of this course, I hope you will be able to:

- 1. understand the vocabulary of business law cases and corporate transactions;
- 2. read and analyze business law cases and statutes and apply them to novel fact patterns;
- 3. understand some of the central policy concerns in business law, and how business law policies may affect the economy and society; and
- 4. further develop your skills as a client counselor, particularly by practicing how to issue-spot in business situations and by understanding what motivates your client.

Required Text:

The required text for this course is ERIC A. CHIAPINELLI, CASES AND MATERIALS ON BUSINESS ENTITIES (Fifth Edition, 2022).

I plan to use Blackboard Collaborate to communicate with the class and to distribute additional course materials, including statutory supplements.

Readings will be assigned weekly.
